## Contest Rules:

- Eligibility: this contest is open to everyone
- Entry Fee: \$2 per entry
- Three Categories: Youth (17 & under), Amateur, Professional

## Category description:

**Amateur:** An adult who considers themselves a beginner or hobbyist, is self taught, has limited art instruction and exhibits for fun and not for sale.

**Professional:** An adult who holds a degree in an art related field. Someone who teaches in an art related field and who has achieved professional quality in their works.

- Subject material must be taken in Illinois and include wildlife
- Photographs must be matted
- Overall size of each matted entry must be no smaller than 8" x10" and no larger than 16" x 20".
- Deadline for submittal will be January 30, 2010 at 2PM. No late entries will be accepted. Entries will be on display at Dickson Mounds Museum from February 6 to March 1. Entries may be picked up after March 3 from the Havana Public Library during the normal library hours which are: 10AM-8PM Monday thru Wednesday, Thursday 10AM-7Pm, 10AM-5PM on Fridays and 10AM-2PM on Saturdays.
- Individuals submitting an entry must fill out and sign an Entry/Waiver form.
- One winning entry in each category will be determined by People's Choice. Voting will begin during the Eagle Day Festival, February 7, 2010, and will continue through February 19, 2010, at Dickson Mounds Museum. Winners and participant list will be posted on February 22, 2010.
